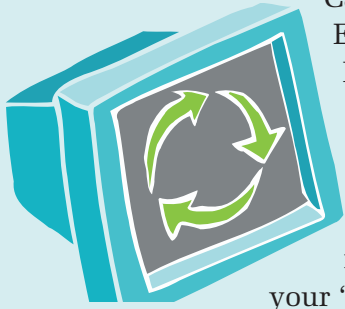


Dumping E-Waste Is Illegal and Costly



California's new
Electronic Waste
Recycling Act,
along with
various federal
and local
statutes, makes
it illegal to discard
your "end of life"

electronic equipment. The
program is run by the California Integrated
Waste Management Board (CIWMB).

In addition to statutes and regulatory rules,
environmental protection officials are also
encouraging organizations to practice the
three "Rs" of good environmental steward-
ship: Reduce, Reuse and Recycle.

Benefits

Services

That assures you that it will be disposed of by a California-certified recycler.

Costs

Call or e-mail NOR-CAL for a quote on recycling costs. For example, if you recycled 10 monitors and five CPUs, the total cost would be \$25 per item. For larger volume shipments, the costs drop significantly to as little as \$10 per item.

Saving the Planet

As technology becomes an ever-increasing part of our lives and continues to evolve, billions of tons of discarded “e-waste” must be managed in a responsible manner. Most electronic devices contain a variety of materials that can be recovered for recycling. If equipment that contains metals can be recycled, less mining will be required.



Equipment like TVs and computer monitors contain high levels of lead and other hazardous wastes that must be disposed of carefully—and

not dumped into municipal trash. Much of the equipment you are discarding can be refurbished for use by others—in this country and in less-advanced nations.
